ANEX 3 COVID-19 PROTOCOL DOC

The COVID-19 health crisis requires the adoption of a number of measures aimed at complying with the protocols set by health authorities. The implementation of these measures requires a signed agreement to follow and comply with these protocols.

The reading and acceptance of this document is a required condition for taking part in the activities organized by the SAN ROQUE RUGBY CLUB.

As a participant in the club's activities you **declare and acknowledge:**

- 1.- That I am aware of the security measures proposed by the club due to the COVID-19 health crisis.
- 2.- That I commit to comply with the guidelines and follow the recommendations issued in relation to measures to minimize the spread of the COVID-19 virus.
- 3.- That I commit to avoid attending or taking part in the activity in the event of symptoms that may be compatible with those of COVID- 19. This will also apply in cases where symptoms were suffered by third parties which I have had contact with.
- 4.- That if I am aware of being affected by the COVID-19 virus, I agree to not attend or take part in any events or competitions as long as the health authorities do not state that participation does not pose a risk, either to me or to the rest of the attendees with whom I may have contact.
- 5.- That by all means possible and when circumstances require it, I will take the necessary steps to be tested to check if I have been infected with COVID-19, and if it is positive I will immediately inform the person in charge of the Club (category delegate).
- 6.- That I have the knowledge, accept, and assume that, in the current state, there is an objective risk of COVID-19 contagion with the consequences that may arise for me in terms of health.
- 7.- I agree that the club will adopt the measures indicated in its COVID PROTOCOL in order to establish a reasonable security scenario. In that regard, it is stated that the club may, in the course of the activity, take the necessary measures or decisions in relation to the establishment or application of the measures contained in its document or any other measures intended to provide the activity with a safe environment in terms of avoiding COVID-19 contagion.
- 8.- That, if infected by COVID-19, the SAN ROQUE RUGBY CLUB will be exempt from any liability in relation to any damages that may arise.
- 9.- I agree that when measures or decisions are taken by the club with the object of preserving the health of individuals in the course of the competition, the essential obligations incurred by the club may not be considered on-compliance, so the payment of amounts, compensation or refund of amounts in terms of registration or participation rights or costs incurred by the athlete may not be required.
- 10.- I agree that, in the case of non-compliant conduct regarding the orders and instructions of the club staff in relation to security measures to prevent COVID-19 contagion is shown on my part, I may be excluded from the activity.
- 11.- I accept that the sports measures set out in the previous paragraph are without prejudice to other responsibilities of the person or that may assume before the competent authorities (including federal disciplinary bodies) as a result of non-compliant conduct with the orders and instructions that apply, either in the sports federative field or in other areas.
